Dear Public Officials:

I thank you, your staff and employees for your continued cooperation with all of us at Painesville Municipal Court. I am grateful to the people of Eastern Lake County District for the opportunity to serve as Judge of Painesville Municipal Court. We have an efficient staff that works well together and the public has been well served.

Painesville Municipal Court serves multiple municipal corporations and un-incorporated townships of Eastern Lake County. The Court is funded by litigants through court costs and fines. Court costs are returned to the City of Painesville and the County of Lake. Whereas, fines are paid to respective governmental agencies. The Court is conscientious that the Court "pays for itself" all the while providing the vital service of keeping the community safe.

The Court handles all traffic and criminal misdemeanors committed within its jurisdiction. It holds initial arraignments, bond hearings and preliminary hearings for felony cases committed within its jurisdiction. The Court handles civil matters with controversies up to \$15,000 as well as evictions. Note the 2022 criminal court cases are decreased by 23.27% compared to 2019 numbers. Court finds that the 2020 and 2021 numbers were skewed based upon the Covid pandemic.

The Court continues to make investments in the Jail Treatment Program (the drug and alcohol treatment program at Lake County Jail), the Court Garden and its community work service program, and the recently embedded Crossroads' employees (drug/alcohol and mental health treatment provider) in the Court. These investments, along with the Court's practice and procedures to be innovative in both punishment and rehabilitative measures to close the gap for recidivism, has had a positive result in recent years.

The Court believes in promoting the integrity of the Court. In doing so, the Court employs procedural safeguards by giving litigants' ability to participate in the case by expressing their viewpoint, consistently applying legal principles, unbiased decisions and transparency on said decisions. Litigants are treated with dignity and their rights are explicitly protected. As such, whether it is an individual, a victim or the state, they are served by explaining and justifying decisions that address the litigants' needs.



RULE 12 (E) (2)

Rule 12 (E) (2) of the Rules of Superintendence provides as follows:

"Multiple defendants or charges in criminal cases, including traffic cases, all defendants shall be assigned separate case numbers.

Where a defendant is charged with a misdemeanor and traffic offense, the defendant shall be assigned one case number. The category selected for the case number and its case type designator shall be that of the offense having the greatest potential penalty."

PROBATION DEPARTMENT SUMMARY

Mission Statement

To enhance community safety through enforcement of Court orders while striving to empower individuals and change lives.

The Painesville Municipal Court Probation Department Employees continue to accomplish the department's mission and goals. Although every year brings about new challenges, the probation department continues to flourish and generate positive outcomes not only for the offenders, but for the community we serve.

In the year 2022, the probation department received one thousand one hundred and eighty-two (1,182) new cases to supervise. One hundred two (102) cases were referred to the Pre-Trial Diversion program, providing the eligible offender the opportunity to have the charge(s) dismissed after fulfilling court requirements. Fourteen (14) presentence investigation reports were also completed by the probation department in the year 2022. The probation department also supervised eighty-nine (89) pretrial bond supervision cases.

In the year 2022, eight hundred thirty-five (835) offenders successfully completed probation, while two hundred thirty-five (235) offenders had their probation negatively terminated. The probation department collected thirty-seven thousand, seven hundred and eighty-seven dollars (\$37,787) in restitution for victims. The probation department administered eight hundred seventy-seven (877) drug tests in the year 2022, and the top three (3) drugs used by probationers were Marijuana, Amphetamine and Methamphetamine. Twenty-two (22) offenders died while on probation.

Per Ohio Revised Code §2951.021, the Court continues to require an offender placed under the control and supervision of the probation department to pay a monthly supervision fee of twenty dollars (\$20.00). In the year 2022, one hundred twenty-four thousand, one hundred thirty-five dollars and seventy cents (\$124,135.70) was collected. The supervision fees were utilized for specialized staff, purchase of equipment, treatment programs for probationers and state mandated continuing education for staff.

The Court also provides house arrest and SCRAM (Secure Continuous Remote Alcohol Monitor) as tools for the probation department to supervise offenders. In the year 2022, forty-five (45) offenders served one thousand seven hundred eighteen (1,718) days on house arrest. Four (4) offenders served one hundred sixty-six (166) house arrest days under the Court's Jail Diversion program (state funded house arrest). In regards to SCRAM (Continuous Alcohol Monitoring), in the year 2022, one hundred six (106) offenders were monitored for a total of five thousand five hundred thirty-nine (5,539) days. It should be noted out of the five thousand five hundred thirty-nine (5,539) days of SCRAM monitoring, the probation department received a 98.8% Sober Days success rate (The 2022 national average was 98.9%).

PROBATION DEPARTMENT (continued)

A sanction the Court continues to aggressively use for offenders is supervised community service. Last year seventy-eight (78) offenders completed six hundred fifteen (615) hours in the Court's Community Service program. The offenders are required to work under the authority of health districts, park districts, counties, municipal corporations, townships and charitable organizations. In September of 2022, Judge Paul R. Malchesky finished his third year of operating the Painesville Municipal Court Garden. Under the guidance and supervision of Walter R. Siegel, non-violent offenders sowed, tended and harvested the one (1) acre garden located at 3740 Center Road in Perry Township. The plants were again donated by numerous local nurseries (Middle Ridge Gardens and Pettiti Garden Nursery. Siegel Farms, Loreto Lafelice, Walker Brother Roofing and Perry Coal & Feed donated fertilizer, seeds and straw.) and an assortment of vegetables were picked (1,921 green peppers, 1,162 cucumbers, 308 zucchini, 61 squash, 18 bushels of green beans, 24 cabbage, 44 eggplant, 190 baskets of tomatoes, and 198 dozen sweet corn) and donated to the Salvation Army, Madison Food Bank, Perry Center, Teen Challenge and Perry Senior Center.



In 1994, Judge Mike A. Cicconetti developed a program for non-violent offenders to perform community service work at the Lake County Court Garden in lieu of serving a jail sentence. Under the guidance and supervision of Walter R. Siegel, the 1-acre garden located in Perry, Ohio, provides harvested vegetables to local charitable organizations.

This year, we were proud to dedicate a new bench at the garden to the two people who began this wonderful community project and "grew" it for nearly 30 years—Judge Mike Cicconetti and Wally Siegel. These two gentleman have upheld the court's mission of enhancing safety through enforcement of Court orders while striving to empower individuals and change lives.

PROBATION DEPARTMENT (continued)

Painesville Municipal Court staff continues to be active with various professional organizations such as Ohio Chief Probation Officers Association, American Probation and Parole Association, Northeast Ohio Probation Officer's Association, City of Painesville Violent Crime Reduction Collaboration Board, and the Lake County Corrections Board. On August 1, 2022, the department welcomed new hire Probation Officer Rob Higginbotham. In October of 2022, officers attended the 2022 Fall Ohio Bailiffs and Court Officers Association Conference in Columbus, Ohio. In March of 2022, officers completed Taser recertification.
